The decision to establish Fitness Training Academy Pty Ltd grew from a belief that opportunity existed to provide a better training experience within the local fitness industry. Beyond the links to KPI Insync, the organisation has no significant partnerships.

Fitness Training Academy Pty Ltd current market is students 18 to 55 years with an interest in working within the fitness industry; however, its main target market is the 18 to 25 year old age group seeking to enter the industry.

Fitness Training Academy Pty Ltd utilise the facilities at PCYC Beenleigh as its main training location, with administration activities managed from the KPI Insync offices at Southport.
